# **Section II: Curriculum**

The specific plan of study for each of the MS, Nursing degree tracks and graduate certificates are noted in the sections below. Questions regarding transfer credit or courses offered on the plan of study can be directed to the MS program director.

The curriculum meets the competencies and program requirements outlined by the American Association of Colleges of Nursing Essentials. Students in all degree tracks (not graduate certificate programs) will complete direct care clinical hours and a role-focused practicum that allows them to work with a preceptor in an area or role best suited to their career goals.

# **Master of Science in Nursing**

The MS program in nursing is ideal for nurses looking to gain advanced education and skills in the translation of concepts, practices and principles of leadership. The degree is designed for nurses who think about the future and are ready to take the next step in their career. This Commission of Collegiate Nursing Education-accredited program focuses on four key areas: evidence-based practice, patient safety and health care quality, informatics and leadership.

Coursework is delivered completely online, providing students with the flexibility to focus on both their education and career goals. Throughout the program, students learn about leadership, innovative thinking and interprofessional team collaboration, and they advance their skills in leadership, research, evidence-based practice, evaluation, critical thinking, health care quality and patient safety.

# RN to MS in Nursing bridge option

The RN-MS in Nursing (Registered Nurse to Master of Science Degree in Nursing) bridge program provides the opportunity for registered nurses who hold an associate degree in nursing to complete a graduate degree without first completing a Bachelor of Science in Nursing (BSN) degree. This new bridge program supports academic progression that is essential to prepare the future nursing workforce to deliver care in the increasingly complex health care system.

This program supports RNs who are seeking to move into specialized roles within clinical nursing practice. The program offers a focused curriculum built upon advanced-level core competencies from the AACN Essentials for Professional Nursing Practice. The program will prepare students for specialty roles in informatics, administration/leadership, public/population health, and health policy.

#### **Program Completion Outcomes (PCOs)**

The RN to MS bridge program meets the same Program Completion Outcomes as the Master of Science in Nursing degree track.

# **Master of Science in Nursing, Nursing Education (NED)**

The country is experiencing a shortage of nursing faculty. This degree program, with a concentration in nursing education, prepares students to advance their career and achieve their goal of becoming a nurse educator in an academic or practice setting. During this program, students prepare to teach future nurses and nursing leaders. Program highlights include:

- academic and clinical assessment
- curricular design and evaluation
- curriculum and course development and delivery
- educational theory and research
- testing and evaluation, including evaluation methods

Coursework in the MS program in nursing is delivered completely online, providing flexibility for students to balance their education and their career.

Courses in this program are led by experienced nursing faculty and designed with active learning strategies. Throughout the program, students learn the key competencies of a master's degree-prepared nurse while they gain additional nursing education skills. Students complete direct care clinical hours and a role-focused practicum that allows students to work with a preceptor in an area or role best suited to their career goals (students can choose to work with a clinical educator or an academic educator during the practicum).

# RN to MS, Nurse Education bridge option

The RN-MS in Nursing, Nurse Education (Registered Nurse to Master of Science Degree in Nursing, Nursing Education) bridge program provides the opportunity for registered nurses who hold an associate's degree in nursing to complete a graduate degree without first completing a Bachelor of Science in Nursing (BSN) degree.

This new bridge program supports academic progression that is essential to prepare the future nursing faculty workforce to prepare new nurses entering practice. To increase nurses in practice,

the first step is training well-prepared nursing faculty. Many nurses currently employed in teaching positions are underqualified with only a bachelor's or associate degree.

The RN-MS bridge program is designed specifically for RNs who have earned an Associate degree in nursing from a regionally-accredited program. The program will prepare nurses to assume educator positions requiring graduate preparation across clinical, community, and academic settings.

#### **Program Completion Outcomes (PCOs)**

The RN to MS, Nurse Education bridge program meets the same Program Completion Outcomes as the Master of Science in Nursing, Nursing Education degree track.

# **Nurse Educator (NED) Graduate Certificate Program**

The Nurse Educator Graduate Certificate (NED certificate) is a non-degree option designed for experienced health care professionals who want to develop the knowledge and skills needed to practice as a Nurse Educator in academia or staff development. The certificate consists of 15 credit hours (five Nurse Educator core courses). It is also available to students in the PhD, DNP and MS programs who choose to supplement their degrees with educational courses.

This 15-credit hour graduate certificate in Nursing Education prepares post-master's registered nurses or those enrolled in doctoral programs and other health professionals to teach in academic or practice settings.

#### Admission

With guidance from the program office, applicants are reviewed by the Edson College student services team, and admission decisions are submitted to ASU Graduate College for final review and offer of admission. All applicants selected for admission will be admitted with contingencies, which will be outlined in the admission email from our academic unit.

Each program within the college is authorized to operate on a state-by-state basis. Students who do not reside in Arizona should review the <u>State Authorization</u> section of this Handbook to confirm if the program is authorized within the state of residence.

#### **Advisement**

Upon admission, students will receive communication from their assigned academic advisor, who will serve as a resource for developing and revising their academic plan, navigating university policies and procedures, and providing guidance related to academic success for the duration of their program.

#### **Enrollment & Registration**

Once admitted to a graduate degree program or graduate certificate program, students must be registered for a minimum of one graduate-level credit hour during all phases of their graduate education. Graduate students planning to discontinue registration for a semester or more must submit a Leave of Absence request via their Interactive Plan of Study (iPOS). There are appropriate circumstances when students may need to withdraw from the university (i.e., medical withdrawal, compassionate leave). The policies for such withdrawals are the same for both undergraduate and graduate students. An approved Medical/Compassionate Complete Withdrawal is valid towards meeting the continuous enrollment policy.

Students are responsible for enrollment in courses each semester, following the program of study for their concentration. Enrollment is completed through MyASU.

#### **Satisfactory Academic Progress**

All graduate students are expected to make systematic progress toward completion of their graduate program. This progress includes satisfying the conditions listed below, and achieving the benchmarks and requirements set by the individual graduate programs as well as the Graduate College. If a student fails to satisfy the requirements of their program and/or the benchmarks outlined below, the student may be dismissed from their program based on the academic unit's recommendation to the Graduate College, at which time the Dean of the Graduate College makes the final determination.

Satisfactory academic progress includes:

- 1. Maintain a minimum 3.00 for all GPAs (see "Grades" section of this Handbook).
- 2. Satisfy all requirements of the graduate program.
- 3. Satisfy the maximum time limit for graduation for the student's graduate program (six years for masters and certificates).
- 4. Successfully complete the culminating experience.
- 5. Graduate students must remain continuously enrolled in their graduate program. Failing to do so without a Graduate College approved Leave of Absence is considered to be lack of academic progress and may result in the Graduate College withdrawing the student from their program. See full Leave of Absence rules below.

#### **Incomplete Grades**

Students completing work for a course in which they received a grade of "I" must maintain continuous enrollment as defined previously. Graduate students have one year to complete work for an incomplete grade; if the work is not complete and the grade changed within one year, the "I" grade becomes permanent and will remain on the students' transcripts. The student will have to re-register for the course to receive credit

A student who requests a grade of incomplete "I" must complete the following steps:

- Submit a request for a grade of incomplete to the instructor of the course. Submit the
  instructor-approved (signed) form to the Program Office by faxing, scanning/emailing, or
  mailing. This contract must be received by the Program Office no later than 5 business
  days prior to the last day of classes.
- Keep a copy of the final contract (signed by student, instructor and program director).
- Notify the Graduate Program Office upon fulfillment of the contract.
- Many courses are pre-requisites for progression in the program. If a student's incomplete
  grade postpones his/her scheduled progression in the program, the student must contact the
  Graduate Program Office immediately to determine how to proceed.
- Unfinished work must be completed with the same instructor except under extenuating circumstances.
- The student must complete the course prior to the stated date on the contract to remove the
  incomplete grade. If no date is specified on the contract, the student has a maximum of one
  calendar year from the date the grade of "I" is recorded before the system converts it to a
  permanent "I."
- After one calendar year the grade "I" will become a permanent part of the transcript. To repeat the course for credit, a student must re-register and pay the required fees. The grade

for the repeated course will appear on the transcript but will not replace the permanent "I."

Students with incomplete contracts may not file for an incomplete in another course until the previous contract is fulfilled, course requirements are met, and a grade change request is submitted.

Note: Completion of an incomplete grade does not satisfy the Graduate College's satisfactory progress requirement. In order to maintain continuous enrollment in a degree program, a student must enroll in at least one course each Fall and Spring semester.

#### Leave of Absence

Graduate students planning to discontinue registration for a semester or more must submit a Leave of Absence request via their Interactive Plan of Study (iPOS). This request must be submitted and approved before the anticipated semester of non-registration. Students may request a maximum of two semesters of leave during their entire program. Having an approved Leave of Absence by the Graduate College will enable students to re-enter their program without re-applying to the university.

Students who do not register for a fall or spring semester without an approved Leave of Absence are considered withdrawn from the university under the assumption that they have decided to discontinue their program. Students removed for this reason may re-apply for admission to resume their degree program; the application will be considered along with all other new applications to the degree program.

Students with a Graduate College approved Leave of Absence are not required to pay tuition and/or fees, but in turn are not permitted to place any demands on university faculty or use any university resources. These resources include university libraries, laboratories, recreation facilities or faculty and staff time.

#### **Program Completion**

#### **Graduation and Convocation**

The student is eligible for graduation when all degree requirements have been met. The student's iPOS must be approved and on file with the Graduate College before the student is eligible to apply for graduation. For further instructions, please review the graduation process here: <a href="https://students.asu.edu/graduation">https://students.asu.edu/graduation</a>.

University Graduate and Undergraduate Commencement ceremonies are the university-wide ceremonies at which President Crow confers degrees. Convocation events are celebrations of individual achievement where graduate names are called and graduates cross the stage. Convocation ceremonies are hosted by the college or special interest group.

The Edson College of Nursing and Health Innovation holds a separate Convocation ceremony in conjunction with the Fall and Spring Commencement. Edson College will send required information to graduates early in the semester providing the information to register and attend. Students who have met all university and college degree requirements are encouraged to participate. It is the student's responsibility to adhere to the convocation timelines.

# **Clinical Placements (Practicum)**

Enrolled MS degree students are required to complete a graduate-level direct care clinical practice experience. The clinical, called a practicum, is a precepted experience appropriate to master's level nursing and health care professional practice. Clinical practicums are designed to build on core knowledge learned in other courses in the program and complement the Role-Focused practicums that may or may not occur in the clinical setting. The practicums are tailored to student interests, professional goals, and population area of interest.

Students must meet the following criteria to be eligible to participate in the direct-care practicum experience. Failure to meet these criteria can lead to delays in the plan of study and program completion.

- Students must have a current, unencumbered RN license in the state in which they are attending a clinical practicum.
- Students are responsible for finding a clinical site and a preceptor for the required direct care and role practicum experiences in the program.
  - The MS program is not responsible for guaranteeing a clinical placement site.
  - The Program Office and Clinical Coordinator will work with the student to establish and approve the clinical site.
  - o Affiliation agreements are required for all direct-care clinical experiences.
  - Contracting for affiliation agreements can take 6-12 months to complete and must be approved by ASU Office of the General Counsel prior to beginning the course.
  - The student's clinical practicum will be arranged in collaboration with the MS clinical coordinator. The clinical coordinator will determine if the site and preceptor are appropriate to accomplish clinical goals.
- Preceptors must be an RN with a graduate degree and an RN license in good standing as mandated by the state board of nursing where the clinical site is located.
- Required practicum hours must be completed during the semester dates only.
- Students must notify the MS clinical coordinator or program office staff regarding any issues related to their preceptor, patient interactions or site (conflict with preceptor, sexual harassment, safety issues, etc.) immediately.

Students must satisfy all requirements and conditions noted in the *Health and Safety Compliance Requirements* section of this Handbook to be able to complete clinical hours.

#### **Clinical Compliance Requirements**

All students are required to meet health and safety requirements, including immunizations, before registering for any course with a clinical, practicum, or internship component. Compliance is completed through an Edson College-designated third-party online platform. Instructions for purchasing an account on this platform will be provided in the student welcome information provided upon admission to the program.

- Students are responsible for all costs associated with these requirements.
- No other forms of background clearance or drug screening are accepted.
- Students are responsible for submitting and maintaining compliance for all required materials throughout the duration of the program.
- Many health and safety requirements, including immunizations, will expire at specific intervals
  and it is the student's responsibility to respond to expiration notices and complete updated
  requirements.

- The Edson College compliance platform will notify the student of any deficiencies, but it is the student's responsibility to maintain these requirements.
- Students cannot attend clinical/practicum courses if any required documentation is incomplete, out of compliance, or expired.

#### **Background Clearance & Drug Screening**

By the first day of the first class in the program, all students will be required to complete background clearance and drug screening. Details about the screenings can be found in Appendix A.

The deadlines for specific requirements are:

- **First day of classes:** Criminal background check and drug and alcohol screen <u>must be completed</u> by the start date of your first class.
- Prior to the first Practicum course (NUR 509):
  - All remaining items must be <u>submitted and approved</u> before you can enroll in your practicum course.
  - Additional requirements may be required by your chosen clinical sites and students will be responsible to ensure these items are in compliance prior to starting their clinical experience.

Students who do not meet these stated deadlines may be removed from classes and will be withdrawn from the program.

ASU is contractually obligated to our clinical partners to ensure all health & safety items are up to date and no items should expire during your practicum semester. It is your responsibility to ensure documents are updated throughout your time in the program (for instance, if your CPR certification expires you are responsible to renew and upload the new document). Renewal dates for all relevant items are listed in the online compliance platform.

#### **Immunizations and Other Requirements**

Additional health and safety requirements are required prior to the first day of the first clinical/practicum course in the program. These requirements are determined by the clinical sites and may change without prior notice. Some of these items can require up to six months to complete, and it will be the student's responsibility to ensure full compliance with all items in time to begin the course. Enrollment in the clinical/practicum course will not be allowed until full compliance lasting throughout the duration of the course has been demonstrated in the compliance platform.

#### **Nursing Licensure**

All students are required to have an active, unencumbered RN license in the State Board of Nursing where they practice. The RN license must remain active and unencumbered throughout the student's enrollment in any nursing program.

International nurses may be eligible for an Arizona registered nurse license and may enroll in the MS Program provided that verification of an RN-equivalent license has been submitted during the application process.

If a license becomes encumbered or expires at any time, the student will be dropped from courses (without guarantee of a tuition refund), and will be unable to enroll in any future courses until the license returns to unencumbered, active status.

#### **Clinical Site Requirements**

Some agencies utilize an additional onboarding system (e.g. myClinicalExchange) for students completing clinical hours in their facility.

- If a fee is incurred, it is the student's responsibility.
- Onboarding to a clinical site that uses this additional onboarding system may include the submission of immunization documentation, TB status, background check, licenses, ID, additional drug testing, orientation, modular training and/or EMR training and any other documentation required by the site.
- The Program Office or the Clinical Coordinator are not responsible for these items, nor do they have any say in the requirements of the specific sites.
- Students are to anticipate that onboarding could involve additional time spent in orientation and/or modular training.
- Any additional costs associated with clinical placements are the responsibility of the student.
- Students are to start the onboarding process immediately upon confirmation of the clinical site. Students are responsible for following the instructions regarding onboarding. A delay in following instructions or not following instructions will place a student at risk for a delay in their course progression.

#### **Academic Affiliation Agreements**

Academic Affiliation Agreements are required to be in place before a student may begin a clinical practicum. Agreements can take 6 to 12 months to execute. Occasionally, ASU Edson College of Nursing and Health Innovation is unable to agree to the terms of an Agreement and the Agreement is not able to be executed. ASU and Edson College have existing agreements with many clinical sites across the U.S. Please check with the Program Office or the MS clinical coordinator if you have any questions.

#### Change of Residence (out of state or out of current area)

Students are required to immediately report any change in address to the Program Office or the Academic Advisor. Failure to do so may result in a delay in the student's course progression, due to clinical placement issues.

If moving out of the area or out of state, please refer to the *State Authorization* section of this Handbook. There are several states where ASU's MS program is not currently offered. Moving to a restricted state could mean that a student will no longer be eligible to graduate from the program. #### **Incident Reporting**

Any incidence of harm or potential harm while a student is at their clinical site while earning course credit must be reported.

Virtually all actions taken with respect to behavior need to have a hearing process (or some opportunity for a student to give a response to allegations made or actions to be taken where removal from a class, or grade appeal process, or suspension or expulsion from school is mandated). The Student Code of Conduct provides for the Dean of Students to act when a complaint is filed with the Educational Outreach & Student Services (EOSS), and for a hearing (informal) to be held where the student is given an opportunity to respond. # **Appendix A**

# **Overview of Criminal Background/Drug Screening Requirements**

#### **Criminal Background Check Requirements:**

- Students must pass the required background clearance obtained from ASU's authorized vendor.
- Students are required to pay for the cost of obtaining the background clearance.
- Background clearances must be completed *within 30 days of notification of conditional acceptance to a clinical program.*
- Students will be required to pass an additional background clearance if they have a break in continuous enrollment in the clinical or research program.
- Students may be required to pass additional background clearances to meet the specific requirements of clinical or research agency partners.
- At all times during enrollment in a clinical or research program, students must maintain a
  passing disposition on all background clearances.
- Enrollment requirements related to background clearances are subject to change as mandated by clinical or research partners.

#### By applying to an ASU Clinical Nursing Program, you are affirming the following:

- 1. I understand that within 30 days of notification of conditional acceptance, I must submit to and pay any costs required to obtain the required criminal background clearance.
- 2. I understand that failure to obtain a "pass" as a result of the required criminal background clearance will result in my inability to enroll in a clinical or research program.
- 3. I understand that a clinical or research agency may require an additional criminal background clearance to screen for barrier offenses other than those required by ASU.
- 4. I understand that I will be disqualified for enrollment in a clinical or research program, if I receive a failing disposition on the required background clearance.
- 5. I understand that I must disclose on all background clearance inquiries all required information including any arrests, convictions, or charges (even if the arrest, conviction or charge has been dismissed or expunged), or participation in first offender, deferred adjudication, pretrial diversion or other probation program. That includes any misdemeanors or felonies in Arizona, any other state, or other jurisdiction.
- 6. I understand that my failure to disclose relevant or required information on all background clearance inquiries will result in a violation of the ASU student code of conduct and may be subject to sanctions under that code.
- 7. I understand that I will not be able to complete a clinical or research program, if a clinical or research agency to which I have been assigned does not accept me based on the results of my background clearance.
- 8. I understand the Arizona State University and the Edson College of Nursing and Health Innovation reserves the authority to determine my eligibility to enroll in a clinical or research program, and that enrollment or background clearance requirements may change without notice.
- 9. I understand that I have a duty to report to the Program Director within 48 hours any arrests, convictions, or placement on exclusion databases.

#### **Drug Screening Requirements**

- 1. All admitted graduate nursing students must provide evidence of a negative drug/alcohol screen before beginning the Master's degree program.
- Inconclusive drug test results or drug test results below acceptable levels for creatinine and specific gravity indicate dilution of urine and may require re-testing at the student's expense. The most common inconclusive results are:

- a. Negative dilute: This result will require a retest at the student's expense. If a second test leads to the same result, the student will be deemed compliant.
- b. Positive dilute: This result will be considered a failed drug test and will lead to expulsion from the program.
- 3. Cost of the Drug/Alcohol Screen is the responsibility of the student. If a second drug screen is required, the cost of this second drug screen is also the student's responsibility.
- 4. Students who refuse to comply with this requirement will forfeit their admission status.
- 5. Students whose drug screen results are positive, and who do not submit data about prescription drugs that may result in a positive drug screen, will forfeit their admission status.
- 6. Students taking prescription drugs may receive a positive drug screen report. Students are advised to request a letter (on the provider's official letterhead stationery) identifying the prescribed drug(s), the reason for the prescription(s), and whether the drug needs to be taken prior to the drug screen. Please contact the Master's program director for more information. All information will be kept confidential.
- 7. Results of your drug screen are sent directly to the Edson College of Nursing and Health Innovation, Graduate Program Office. All results are confidential.
- 8. The drug screen will include all substances required by the clinical site.
